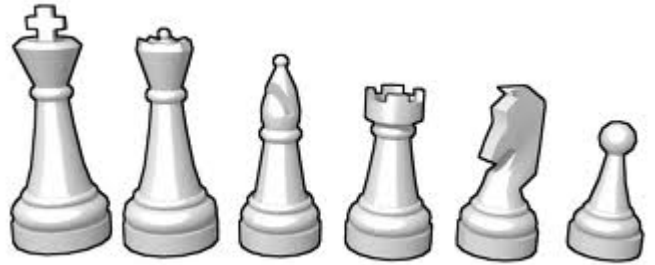

DIVISIONS:

Jr. Varsity: K-2 grade, 3-6 grade, 7-12 grade (this in a non-rated division, USCF membership is not required)

Varsity: K-2 grade, 3-6 grade, 7-12 grade (USCF membership required – **4SS, G/30, d0**)

Age sections may be combined or modified if necessary

ENTRY FEES:

Pre-registration is \$5. Money and registration must be received by February 25. **On-site registration is limited and will cost \$10.** Make checks payable to Lake International School Chess Club.

TIMES:

Check-in 8:00-8:30 a.m. Player meeting (all competitors must attend) at 8:30 a.m. Four games– First game is at 9:00 a.m. ***This is a non-elimination tournament – all players will participate in four rounds.***

PRIZES:

Trophies will be awarded to the top 3 finishers in each division and participation awards will be given to all non-trophy winners.
